What have you bi-culturally contributed to your Playcentre | Ropū Māori?

Since the beginning of my Playcentre journey I have launched into everything with all my all, including the perspective that I bring as a Māori woman. I have always had incredible passion for Māori tamariki especially within mainstream education. My years working in the New Zealand Education system has meant that I bring a passion for ensuring success for Māori is achievable in a Māori way. This was evident in my first two years at Playcentre where I held two officer holder roles; Bicultural officer and L.E.A.P officer. I was able to support whānau with planning, teaching and learning, to ensure play and bi cultural practices were embedded and implemented in a very real and authentic way for our tamariki and wider whānau.

Within a wider Playcentre setting I have always taken the opportunity to work alongside other Playcentres in our Auckland cluster and local ropū; Ngā Te Rito Puriri Whakamaru. Historically Te Rito has been a proud and prominent ropū within our region however after the amalgamation Te Rito was not minuted as a recognised ropū. I was one of two Playcentre members that went to work and Te Rito Puriri Whakamaru was "reawakened". Our ropū has grown exponentially since we first reached out to whānau Māori within our cluster. Connecting with other Māori members has been challenging given our current climate but I feel proud of our ropū; it's rapid growth, it's engagement in governance and it's willingness to work together to provide opportunities for whānau Māori in our centres. Te Rito ropū, alongside our Auckland cluster is working on larger initiatives such te reo sessions in centres and developing workshops with a focus on te reo and tikanga for all centre members within the cluster.

What will you contribute to Te whānau Tupu Ngātahi o Aotearoa?

I bring a passion for learning and my extensive experience working within the many facets of the New Zealand Education system including my incredible Playcentre experience. I'm passionate about grassroots governance, emergent leadership and Māori voices being empowered in decision making processes. I'm a staunch advocate for Playcentre because I truly believe in te whānau tupu ngātahi so I'll often find myself getting in and doing the work that needs to be done so that our centres, ropū and governance spaces are thriving.

The high quality early childhood education Playcentre provides and my deep belief in the Playcentre philosophy drives me to work for success in a post amalgamated Playcentre Aotearoa. I believe the load of centres has grown over the last 3 years and will continue to increase in this current climate. Our Trustee Board needs to understand the increased expectation of our membership and how they can ensure that the outcomes of amalgamation are realised, for example an operational arm that employs and retains quality employees with Playcentre experience and a Trustee Board that fosters grassroots governance ensuring all centres and whānau Māori have a voice.

I believe good communication, transparency and the ability to work in partnership is paramount in ensuring the success of Playcentre Aotearoa in the years to come. I believe I bring these skills to my Playcentre and to all the spaces I work and volunteer in.

I thrive in a team environment, working to understand the big picture and then implement practical and actionable ways to achieve outcomes. I bring a passion for initiatives and projects that support centres and ensure whānau Māori thrive within the mainstream setting that is Playcentre.
