### EDUCATION AND SKILLS THAT WOULD ADD VALUE TO THE TRUSTEE BOARD

#### ***What have you bi-culturally contributed to your Playcentre | Rōpū Māori?***

As centre president, I implemented an internal review within our centre to address increasing knowledge of te reo and Te Ao Māori, which has seen the inclusion of a number of new practices, such as core use of natural materials, bi-lingual signage with te reo first and foremost to promote vocabulary and we have a monthly set of phrases to practice in every day conversations with our tamariki.

Since signing on as a representative, I discovered there was no local rōpū representation in our area and have been actively trying to support the creation of a rōpū with whānau māori in our area / cluster.

With also acknowledging our lack of bi-cultural practices I have also enrolled in a number of PLD through external sources around best practice of bi-culturalism in ECE environments and am enrolled in June on Bi-culturalism in leadership course to continually upskill myself in this area.

I see this as a continual journey and something that we can only do through looking at ourselves, our practices and building reciprocal relationships.

#### ***What will you contribute to Te Whānau Tupu Ngātahi o Aotearoa?***

I have been a small business owner for the last 11 years and have had the amazing opportunity to be a consultant with a number of organisations from all around the world. It has given me a great perspective on how different companies run and how to move a company from an immature blank slate to a more stable company, without losing their uniqueness and missing some of the pitfalls that businesses can fall into. I have mainly sat with the operational side of organisations, but as an outsider looking in, I can see these skills transferring nicely to be able to support steering the organisation from a governance point of view.

I love Playcentre and want to see it thrive, and I want to ensure that we are set up to have the right conversations. I think we have a tough and long bumpy road ahead, but we are a blank canvas at the moment. If we ask the right questions - who are we? What do we want to be? How do all of our stakeholders communicate internally & externally? What makes us unique and how can we retain this while meeting our regulatory requirements, we will find that we fix the many challenges facing us today.

***What will you contribute to the Trustee Board?***

I believe I will contribute my business and financial acumen, as mentioned above, but I will also contribute a voice from the centre. At the moment, our trustee board is made up of life members who bring their wealth of experience, but being at centre and seeing how the current decisions affect us in real time gives me a different perspective and a real time point of view.

I am also from Tamahere Playcentre which is semi-rural and south of the Bombay Hills which again offers some diversity amongst the current trustee board members.
